1. **Call to order 5:38 p.m.**
2. **Approval of Minutes of September 10, 2014 Board meeting** Motion made by Laura to approve the minutes from October 8, 2014, Terry seconds the motion and the motion passes.
3. **New Business**
  - 3.1 **Thurston County Clerk's Candidate Forum Update**
