#### 3. **New Business**

- 3.1 Discussion of proposed court rule regarding establishing a program for judicial evaluations A discussion took place and the group decided to form a committee, Trevor, John, Chris L. and Megan, will meet and present at the next meeting.

Mark Wheeler, Chris Lanese, Terry Church will form a committee to develop a proposal to the Superior Court Judges to develop an alternative option to the courts current policy regarding setting Summary Judgement motions and Trial scheduling issues.

- 8.4 Criminal Defense (Paul Strophy)- We had a meeting last month (January) that also included Daryl Rodriguez of OAC and representatives of the County to discuss issues with the recently proposed contract for private practice attorneys who do contract work with OAC, as well as issues with the contract rates. It was agreed that the terms of the contract would be worked out between a couple local defense attorneys who volunteered and a deputy prosecutor from the civil division. The issue with the contract hourly rates, which are some of the lowest in the state, was relayed to the Board of Commissioners representative and will be an ongoing issue.

Also discussed at the meeting was determining a regular meeting time for the criminal law section (e.g. second Thursday of every month at 12:00 p.m.), but were unable to come to a consensus. I hope to have a regular day of the month and time picked out soon. Finally, at the Superior Court criminal management meeting, the TCSC criminal presiding judges will not require lawyers confirming trials to use a trial confirmation form to be placed in the court file. The committee is also continuing to explore new electronic document ("Edocs") programs/vendors as the system currently being used has proven to be too slow and inefficient in the opinion of the board of judges.
