- 1. **Call to order** 5:35pm

## 8. Section Reports

- 8.1 Family Law (Paul Battan) We sent out a newsletter at the end of April, for May, and will be having our monthly noon meeting May 10. Shelly Willis, the executive director of Family Education and Support Services will join us as a speaker.

  I have received quite a few complaints or concerns over the last two months about procedural matters that the court is changing because of Odyssey or for other reasons. Many of these create some burdens on practitioners. We discuss these issues at our meetings at which judicial offices are present, but I do not feel that the court is particularly sympathetic or responsive to the bars' concerns. Well . . . we will keep trying.

  One member contacted me to complain about receiving emails from candidates. I do not know if she thought the candidate used the Family Law Section email list but he did not. I assume the TCBA has its own policy on the use of its email list by candidates. I told her I would bring the concern to your attention.
- 8.2 Pro Bono (Chris Lanese) The stakeholders from the different groups involved in the Joint Committee regarding Direct Representation had an initial meeting. The representative from TCVLS will take the lead on coordinating the process and future meetings.
- Young Lawyers (Megan Rue) We swore in four new attorneys at a formal swearing in ceremony on Thursday, April 14<sup>th</sup>. The Honorable Judge Carol Murphy presided over the ceremony.
   The new and young lawyers continue to meet monthly for lunch and will be collaborating with the WSBA YLC to host lunchtime CLE this summer.
- 8.4 Criminal Defense (Paul Strophy)- no report
- 8.5 Real Estate, Land Use, and Environmental Law Committee (Martha Wehling) The Real Estate, Land Use, and Environmental Law Section has three meetings planned for the remainder of 2016, following our March presentation from Neil Wise on fishers and wolves. On Tuesday, June 7, J. Vander Stoep, a Chehalis attorney, will present on local government regulatory challenges, using the Chehalis Basin flood reduction effort as a case study. Mr. Vander Stoep is part of the Governor's Working Group and has been involved in the project since the 2007 flood. The effort proposes limited retention with extensive river habitat restoration. Mr. Vander Stoep will discuss the decades-long effort to address the problem in Thurston, Lewis, and Grays Harbor counties.

Ann Harrie, with Bean, Gentry, Wheeler & Peternell, is coordinating a panel for a ½ day Land Trust CLE. We anticipate holding this CLE either the first or third week of October. Finally, later in the fall, Joanna Eide, the Policy and Rules Coordinator for the Washington Liquor and Cannabis Board, will present on the ongoing implementation of the recreational marijuana laws.
