1. **Call to order** 5:41pm

2. **Approval of Minutes of January 9, 2019 Board Meeting -** Megan moved to approve, seconded by Patrick. The motion carried without objections.

3. **New Business**

- 3.1 Welcome and Introduction of Victoria as our new Board Member Mark welcomed Victoria to the TCBA Board of Directors and all board members present said hello, but since Victoria attended the meeting by phone introductions will be done at the next meeting.
- 3.2 Campaigning for the New Courthouse Project (Patrick) Patrick shared that Judge Buckley asked him if he could ask the TCBA Board to help with campaigning and support for the new courthouse project. A discussion took place. Patrick will ask Judge Buckley to attend the March board meeting because the board would like to have more information about this. Heather will add this to the agenda as the 1st agenda item for the March meeting. Patrick will ask Judge Buckley to submit his agenda before the meeting so the Board can be prepared for the meeting. Mark will invite Jonathan Sprouffske, who is on the New Courthouse Advisory Committee, and Marie Docter, who is the TCBA New Courthouse liaison, to the meeting as well. Mark will ask them to share what they feel they are accomplishing and not accomplishing during the meetings they go to about the new courthouse.

4. Old Business

- 4.1 Rules Committee update (Laura) The committee met on January 15, 2019 and discussed the timeline for addressing changes to the local rules. Any proposals to the local rules must be provided to Comm. Zinn on or before March 15, 2019.
 - I contacted the Criminal Section, Family Law Section, Young Lawyers, and Real Estate/Land Use section and provided them information regarding proposed changes to the local rules. An email was sent to the TCBA members and we will send another early next week.
 - Last year, one of the judicial officers made comments and proposed changes to ensure consistency in the rules. I agreed to type up the notations for the committee. Unbeknownst to me, there were over 130 proposed changes and/or comments. The five page document was provided to Commissioner Zinn on February 1, 2019.
 - It would be helpful if we held the Spring Bench Bar meeting after March 15th and before the comment period has expires which is approximately May 15th. I will coordinate with TCBA, Comm. Zinn and Judge Schaller to ensure we have dates available.
 - The next two committee meetings are scheduled for March 19th and April 16th. I am scheduled to be out of state in training on March 16, 2019. If anyone is available to cover, that would be great. Otherwise, Comm. Zinn has agreed to send me an update after the meeting.
- 4.2 Coming up with a clear plan to support the new courthouse update (Mark) See 3.2 above.

- 4.3 2019 Law Day update (Terry) In Terry's absence, Patrick shared that the preliminary round will be on April 11th at the courthouse with 2 courtrooms. Patrick has invited two judicial officers to help with the judging. The finals are on April 30th at the Rotary meeting.
- 4.4 Judicial Evaluation Survey update (Trevor) A discussion took place. Trevor shared the proposed questions. Megan suggested sharing the proposed questions with the Judicial officers to see what their thoughts are and if they have questions they want to add. Trevor will send it to the judges and will work with Heather to send it out to the members on or about March 1st. The surveys will be sent electronically, but paper will be available if requested.
- 4.5 Annual Meeting update (Trevor & Heidi) The committee met and decided to stay with Indian Summer Golf & Country Club as the venue because of the short time line to organize the event. The event will be on Saturday, May 4, 2019 at 7:00 p.m. and will include hors d'oeuvres, drinks, meeting, trivia, and music/dancing. Bill moved to approve the planning committee moving forward with planning as proposed, seconded by Megan. The motion carried without objections.
- 5. Treasurer's Report (Jim Laukkonen) January 2019 Financial Report & Annual Book Review Megan moved to approve, seconded by Patrick. The motion carried without objections.
- 6. **Monthly Luncheon Update** (Laura Murphy) In January, Comm. Lack presented a CLE on "Implicit Bias." The CLE was very well attended and the feedback very positive. On 2/15/18, Ret.
