1. **Call to order** 5:35 p.m.

2. **Approval of Minutes of October 9, 2019 Board Meeting** Trevor moved to approve the minutes, seconded by Amy. The motion carried without objections.

#### 3. **New Business**

- 3.1 Website upgrade (Heather) Heather shared that the website designer, Jill Carter, gave us a quote to do some upgrades on the TCBA website. Trevor and Laura will look into the contacts they know about website contractors to get other bids.
- 3.2 Law Students & Young Lawyers at TCBA events (Laura) Laura shared that she would like to invite students and law students to attend the TCBA events. The students can sign up prior to the event for free if the event is not sold out. Laura moved to allow students to attend CLEs free of charge provided that there are no additional expenses to the TCBA, seconded by Geoff. The motion carried without objections.

- 7.3 Newsletter (Heather) The Legal Brief was mailed last week. The deadline for articles and ads for the January 2020 Legal Brief is December 20<sup>th</sup>.
- 7.4 New Courthouse (Marie Doctor & Trevor Zandell) Marie shared that as of today, November 7, I can tell you that the commissioners are reviewing the ballot measure because there was a claim that the original vote was not done properly. There was a public hearing and there will be a re-vote on Tuesday, November 12<sup>th</sup>. The new ballot measure will have some changes to it from the original, including the removal of the site. The measure will simply address the need for the courthouse facility and the financing/levy lift plan with the site to be determined at a later time if the ballot measure passes. I will try to get the additional information to you after the re-vote on the 12<sup>th</sup>, but it will depend on how long/late the meeting goes on Tuesday.

Trevor shared that the commissioners re-voted to put this to the voters in April 2020. The new ordinance does differ in a couple of ways; qualified seniors, veterans and seniors will be exempt from the tax increase and the board took the Plum Street location out of the mix. The City of Olympia has not said exactly what the City will provide towards this project. The Yes committee does continue to work on presentations. They are focusing on fundraising and outreach. They are working on an event with the Commissioner as the keynote speakers at events. If anyone knows of any groups where the committee can come speak to let Trevor know.
