3. **New Business**

8. Section Reports

- 8.1 Family Law (Meredith Gerhart) No report. They had a section meeting on April 12.
- 8.2 Pro Bono (Geoff Hulsey) Need TCBA Board member on TCVLS Board Joe Scuderi volunteered to be on the TCVLS board.
- 8.3 Young Lawyers (Devin Kohr) The young lawyer section had its first gathering on March 31, 2022. We had a nice turnout of about 7 people. I noticed most of the people who attended the meet-up are not on the updated list. The next meet-up is planned for Thursday, April 21, 2022, at noon. I am trying to alternate between an after work and a lunch event every other month. I received the bar exam past list this morning from the WSBA. I am sending out an email asking people to RSVP for the swearing-in ceremony that is scheduled for April 22. Honestly, we may need to switch to a Zoom ceremony or possibly only have the applicants be in person and invite friends and family to watch via Zoom. Due to social distancing requirements, we can only have about 45 people in the courtroom. I have already had three people reach out to me asking about the ceremony.
- 8.4 Criminal Law (Angela Colauita) No report at this time. Heather shared that Lindsey Trakel has taken a new job at the Thurston County Public Defense Office, so is no longer a co-chair of this section.
- Real Estate, Land Use, and Environmental Law (Heather Burgess) The section held a 8.5 virtual lunch meeting on April 13, 2022, with Chief Justice Stephen Gonzalez as the Guest Speaker. Eight members of the section attended. Justice Gonzalez shared his "Perspectives from the Bench" on a range of topics pertaining to real estate, land use/zoning, and environmental law, including highlights of some recently decided cases. One question that came up from our members during the discussion was about the status of the volunteer program that had been established by the Thurston County Auditor's office to help property owners remove restrictive covenants from their title under the new legislation, which several of us had signed up for. I believe this came out of the TCBA DEI section, but several in RELU had volunteered. I know as of last spring there had been no requests for assistance, but if the Board is aware of any additional activity in this area, I'd like to be able to share that with the section. I'm pleased to share that Justice Gonzalez committed to participating in another section lunch meeting next year. I anticipate holding a final section meeting in June before taking a summer hiatus; planning an informal section networking Happy Hour, location and date TBD.
- 8.6 Diversity and Inclusion (Zelena Jones & Jessica Shen) Due to busy schedules, we will not be holding a meeting in April, which means that **our next meeting will be Wednesday, May**

18, 2022, at 12pm. Broadly speaking we'll be discussing what groups are and are not usually included in discussions regarding diversity and inclusion and why those assumptions may exist. As part of that, we will also be touching on the films CODA (which was nominated for multiple Oscars and just won for best picture) and Minari (also nominated for multiple Oscars and won for best supporting actress.
