- 1. **Call to order** 5:35 p.m.

#### 3. **New Business**

- 3.1 Newsletter & Electronic version (Heather & Heidi) Heather is working on the May Legal Brief. It will be sent to the members at the end of May/beginning of June.
- 3.2 Diversity & Inclusion Section CLE July 20, 2022 (Heather) Heather shared the CLE Submission Form submitted by the co-chairs of the Diversity & Inclusion Section with the board. The board approved the CLE.
- 3.3 Applications for TCBA Board vacancies (Geoff) A discussion took place. Brandon moved to appoint Melissa Goldmann for position #3, seconded by Wayne. The motion carried without objections.
