- 1. **Call to order** 5:39 p.m.
- 2. **Approval of Minutes of January 11, 2023, Board Meeting -** John moved to approve the minutes, seconded by Bill. The motion carried without objections.

3. **New Business**

- 3.1 Bigelow Award Nomination Form (Heather) Heather sent the Bigelow Award nomination form to the board to review. The board did not have any changes to the form. Heather will email it to the members.
